



92Y Residence Rules and Regulations:

COVID-19 Amendment (Effective 4/15/21)

In order to provide a safe living environment for our residents during these unprecedented times, please find the following COVID-19 amendments to 92Y Residences Rules & Regulations.

General Precautions to Be Adhered to:

- Residents must always wear a mask covering both nose and mouth, when in communal areas and throughout 92Y. The following are not acceptable: gaiters, bandanas and masks with vents.
- There can be a maximum of 4 people in an elevator at a time.
- Maintain social distancing (6 feet where possible).
- Please wash your hands frequently for 20 seconds or use hand sanitizer (which is located throughout the building) when unable to wash your hands.
- If you have a fever or do not feel well, please notify the Residence Office and consult with your physician on next steps.
- Day or overnight guests are suspended until further notice.

In Your Room

- Housekeeping services are suspended until further notice.
- Cleaning supplies can be borrowed from the Residence Office.
- Trash bags for your room can be picked up from the Residence Office and you can discard your trash in the trash bins on your floor.
- You are allowed to have at most 1 other resident in your room at a time. Both residents must be wearing a mask.

Kitchen/Dining Room

- There can be a maximum of 1 resident in the North Building kitchen at a time.
- There can be a maximum of 3 residents in the South Building kitchen at a time.
- There can be a maximum of 2 residents in the North Building dining room while maintaining social distancing.
- Please wipe down all surfaces (kitchen counter, range knobs/handle, refrigerator handle, freezer handle, tables, etc.) before and after use with provided disinfecting spray and paper towels.
- Wash your dishes and utensils after using the kitchen and take back to your room. Anything found in the kitchen will be discarded.
- Do not share dishes, drinking glasses, cups, or eating utensils.
- Residents may only cook for themselves and not anyone else.

Bathroom

- There can be a maximum of 3 residents in the bathrooms at a time while maintaining social distancing.
- Avoid placing personal items (including toothbrushes) directly on the surfaces.
- You are encouraged to use a shower caddy/tote to bring your personal items to the bathroom with you and back to your room.

Laundry Room

- There can be a maximum of 1 person in the laundry room at a time.
- Please wipe down all surfaces on the washing machine and dryer before and after use with provided disinfecting spray and paper towels.

Resource Room

- There can be a maximum of 2 people in the Resource Room at a time.
- Please wipe down all surfaces before and after use with provided disinfecting spray and paper towels.
- Open window to permit proper air circulation.

Communal Area Cleaning

- Kitchens, bathrooms, dining rooms will be cleaned and sanitized at least twice per day and as needed throughout the day.
- Stairwell rails and exit push bars will be cleaned and sanitized once a day.
- Elevator button panels will be cleaned and sanitized twice a day.

Required Testing for SARS CoV-2 (Covid-19)

92Y now requires all residents to be tested for SARS CoV-2 (COVID-19). **New residents will have to be tested prior to arrival. All residents, including current residents will have to be tested by the 15th of every month moving forward.** All residents will be required to submit their test results to the Residence Office by the 15th of every month. Residents that have received their full vaccination doses will still have to be tested on a monthly basis. If your test result comes back positive for COVID-19, you are required to inform the Residence Office. You will be required to make arrangements to return home or move to an offsite location which will provide a more suitable environment for recovery. If you need any assistance in making these arrangements, contact the Residence Office or you can call NYC 311 to make arrangements with the [New York City COVID-19 Isolation Hotel Program](#). Once cleared by a medical professional, you will have to submit your clearance to the Residence Office, and you will be allowed to return to 92Y Residence.

While you make your arrangements, you will be required to move to a designated room on an isolation floor immediately.

If you cannot find an offsite location to move temporarily, please contact the Residence Office.

If you choose not to move to the designated room within 92Y Residence, you will be required to move out immediately.

92Y Lobby Entrance Protocol

The 92Y Lobby Entrance protocol is a 4-point check-in process. When residents walk through the front door, they will be greeted by a 92Y staff member, who will do the following:

1) Mask Check

- Masks are required by everyone to enter the building
- Masks must cover both nose and mouth
- The following masks have been shown to be less effective in preventing the spread of the virus, and are therefore not acceptable: Gaiters, Bandanas, Masks with vents

2) Temperature Check

- A Touchless thermometer will be used to take temperatures
- Residence Team will be notified for temperatures recorded 100.4 degrees or higher.

If you have a temperature of 100.4 or greater, you're required to:

- Go to your room
- Strictly comply with 92Y Covid-19 Health and Safety Protocols as stated above (i.e., wearing a mask, hand washing, disinfecting all surfaces after using, social distancing).
- Monitor your temperature and symptoms over the next day or two.

- If you have a continued fever, a cough, and/or loss of smell and taste, contact your doctor, or a local healthcare professional. For more info, visit or call NYC 311.

3) Health Screening Questionnaire

Upon entry into the building, you will be asked and expected to answer the following questions.

- Are you experiencing any of the following symptoms that the CDC recognizes as being associated with COVID-19: fever/chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting, diarrhea?
- Have you tested positive for COVID-19 within the past 14 days, or do you have any reason to believe that you would test positive at this time?
- To your knowledge, have you been exposed to other person(s) that have either tested positive for COVID-19 or have the symptoms associated with COVID-19 listed in Item 1, above?
- Have you been requested by any government entity or any medical provider to quarantine or self-isolate to prevent against possibly exposing others to COVID-19 within the past 14 days?
- In the past two (2) weeks, have you traveled internationally or traveled domestically to an area where the transmission of COVID-19 is widespread?
- If you answer “yes” to any of these questions, you will be asked to go directly to your room and the Residence Team will be notified.

4) Hand Sanitizer

A 92Y staff member will instruct you to apply hand sanitizer using the dispenser at the front entrance.

As the current situation continues to change rapidly, we reserve the right to make further amendments to these 92Y Rules & Regulations, as necessary.

In signing this amendment, you agree to comply with all the above rules & regulations. You understand that failure to follow these rules & regulations will result in disciplinary action, including being required to vacate your room at the 92Y Residence.
